Matter taken up again after lunch sessions. Judgment announced. Vide my separate judgment of even date, accused has been held guilty for commission of offence punishable under Section 138 of Negotiable Instrument Act and is convicted thereunder.

Heard on quantum of sentence. Vide separate order, convict is sentenced to simple imprisonment for Two years and the complainant is awarded compensation to the tune of ₹93,20,000/-(₹Ninety Three Lakh Twenty Thousand Only) to be paid by the convict to the complainant for loss and injury suffered by him, within 30 days and in default convict shall further undergo simple imprisonment for one month. Compensation amount to the tune of ₹93,20,000/-(₹Ninety Three Lakh Twenty Thousand Only) has not been paid by the convict. It is further clarified that the period of sentence already undergone if any during the trial of this case is ordered to be set of.

At this stage, an application for suspension of sentence under Section 389 of Code of Criminal Procedure is moved on behalf of the convict. Heard. Since the convict wants to assail the order of the conviction and sentence passed against him, his sentence is suspended for thirty days subject to his furnishing the bail bonds in the

sum of Rs.50,000/- with one surety in the like amount. Requisite bail bonds furnished, accepted and attested. Intimation regarding the surety be sent to the registering authority/revenue authority accordingly, as per the directions issued by Hon'ble Punjab and Haryana High Court. The convict is released on the temporary bail for a period of thirty days. The papers regarding the suspension of the sentence be separated from the file and file be put up before the court of undersigned on 01.05.2023 for awaiting of the orders from the learned Appellate Court and/or for surrender of the convict as the case may be. File be consigned to the record room after due compliance.
